

SHORT STAY TOURING CONDITIONS 2024

- 1 You must report to the wardens office upon arrival before pitching.
- 2 **No refunds or transfers will be made under any circumstances. Please ensure you take out adequate travel insurance to cover the cost of your booking.**
- 3 No arrivals after 9.00 pm.
- 4 Bank Holidays are subject to a minimum four night stay.
- 5 The hire of pitches is restricted and it is therefore advisable to BOOK IN ADVANCE.
- 6 **Strictly no jet skis, boats or similar craft. Gazebos, event shelters, open fires, disposable BBQ's, lanterns, flags, kites and fireworks are not permitted.**
- 7 We are a family park and do not take single or mixed group bookings.
- 8 A pitch is one caravan/motorhome/tent and one vehicle only.
- 9 **The amount of people occupying a caravan/motorhome is restricted to the berth of said unit stipulated by the manufacturer. If it is found that your caravan/motorhome is overcrowded you may be asked to leave.**
- 10 Hirers are not permitted to use motorised cars, vans or additional motorhomes as supplementary sleeping accommodation.
- 11 Vans/commercial vehicles are not permitted onsite with any caravan/motorhome booking.
- 12 The Booking Fee includes one car per pitch. Additional cars are charged at £5.00 per night (maximum of 2 cars per booking).
- 13 Pitches must be vacated, not later than **11.00 am**: new arrivals are not to arrive before **12.00 pm**.
- 14 Touring caravans/motorhomes must be sited within the designated area, by the site warden and allocated at the Park Managers discretion.
- 15 Vehicles are only permitted on the park, if they are insured against third party risks and the driver holds a current driving license.
- 16 Charging of electric vehicles is **NOT** permitted on the site using your pitches electrical supply.
- 17 **We do not allow any motorbikes, motorised scooters or similar vehicles on the Park.**
- 18 In the interest of safety, the flying of kites is not allowed on our holiday park.

- 19 To safeguard children and the elderly, a speed limit of 10 M.P.H. is enforced on site. Any person exceeding this speed, or otherwise driving in a heedless fashion will be obliged to take their car offsite.
- 20 The owner of any caravan/motorhome not displaying the correct tag issued by reception will be liable to pay for an additional night's pitch fee.
- 21 Please respect other guests. Noise, music or any other nuisance will not be tolerated after 11.00pm.**
- 22 Please use the litter bins provided. Please also ensure that the toilet and shower facilities are left in the condition you would wish to find them.
- 23 Smoking is prohibited in the Toilet and Shower block.
- 24 Our facilities are closed for cleaning at various times during the day. You are advised to check our cleaning schedule upon your arrival, which is on display on the noticeboard.
- 25 Our Out of Hours emergency numbers are available in the reception and in the wardens office.
- 26 The Company cannot guarantee the occupation of any preferred pitch to any prospective hirer.
- 27 St. David's Leisure shall incur no liability whatsoever in the event of any part of the site or any of the facilities being unavailable because of unforeseen circumstances or circumstances beyond the Park's control.
- 28 St. David's Leisure and its employees shall not be liable for any loss, damage to or theft from any caravan, tent or other property, unless the same be caused or contributed to by negligence or default on the part of the Company, its servants or agents.
- 29 Hiring fees are accepted on the understanding that these Conditions are complied with. St. David's Park reserves the right to terminate permission to occupy any pitch, if in the opinion of the Manager, the person concerned has not complied with the above Conditions or with any Regulations posted on the Park Notice Board by the Management, or in the opinion of the Management, has acted in such manner as to require his/her immediate removal from the Park. The refund of the appropriate proportion of any fees paid in advance shall be sufficient discharge of all obligations to any person who is required to leave the Park for these reasons.
